I also advocated for opening the K&I Bridge, though it appears that simply will not happen without litigation led by the cities involved. The second advocacy role is to grow grass roots support by promoting the fun and benefits associated with cycling and working to expand our community and promote interest in membership in the Louisville Bicycle Club. I expanded our outreach through social media. That would remain a priority. I would also continue working to develop communication with other cyclist organizations in our community to find issues of common concern.

### **Candidate for VP Racing Bill Carey**

I have been VP of racing for the Louisville Bicycling Club for the past year and a half. I have learned a great deal and continue to learn more by the day. There is a great deal of room for improvement in the interaction between the club and the race squad and I would like to make that my focus for the next year, should I be reinstated for another year. I would like to make a budget for the team to stick by. I would like to make the connection between the club and the team more obvious, starting with the club's name being more prominent on the racing kit. I would also like to build a web site or page with the team's roster and activities so it is easier for the entire club to see what we are doing. I plan on promoting one race again this year at Long Run Park on March 15. This is an extremely popular race and serves as the unofficial kickoff to the race season. Thanks for your consideration.

In this issue of the newsletter you will find the Annual Financial Report as called for in the club's by-laws. This report has three parts:

#### I. Overview

As approved by the Executive Committee of the club, the LBC changed its tax year from a calendar year, to a fiscal year of February 1 to January 31, beginning in 2013. This change was made in order for the tax year to coincide with the cycle of activities of the club. At a point in the past, the annual banquet was moved from December to January. This meant that the cycle of the club's activities for the year extended beyond December. In addition, expenses for OKHT were sometimes not paid until after the first of the year. Moving the end of the year to January 31 allows the capture all the income and expense for the banquet and OKHT into the appropriate accounting period. In addition, the cash balances reported at year end are no longer inflated by nonpayment of banquet expenses.

The result of this change was that a special "Short Year" tax filing was necessary, covering the period of January 1 to January 31, 2013. That tax return was filed in a timely manner with the IRS.

#### II. Statement of Operations - Short Year Operations

For the period of January 1 to January 31, 2013, revenues consisted of membership dues, banquet receipts, merchandise sales, and brevet fees, totaling \$1,917.

Expenses included banquet and awards, insurance and CX Worlds, totaling \$16,621.

The resulting deficit was \$14,704.

A full breakdown of income and expenses is included.

#### III. Statement of Operations and Changes in Fund Balances – Calendar Year 2012 to Fiscal Year 2013

There are three parts to this spreadsheet. The first is the Statement of Operations, which sets forth the income and expenses for FY2013, as well as a column for the prior year's results for comparison (which in this case is Calendar Year 2012). The club uses cash-basis reporting.

The second part is a breakdown of revenues and expenditures by program, and the final section reports our Changes in Fund Balances and membership statistics.

I am happy to report that your club is in very good financial health. Some key points from this year's report include:

- Overall revenues were up \$11,225 (10.7%) Expenses were up \$14,605 or 14.5%. Revenues exceeded expenses by \$756.
- The OKHT realized a surplus of \$16,466.
- The racing team had a shortfall of about \$7600 due in part to equipment, in addition to team kits, given to team members.
- Fund balances for the racing team declined approximately \$9000 to just under \$11,000.
- Excluding the racing team, the club generated a surplus of about \$8400 in FY2013.
- Fund balances for the general account declined almost \$5000. [As noted above, this was due to the one-time deficit in the "Short Year".]
- The number of members increased 65 from the prior year.
- The club achieved savings of nearly \$1700 by charging sales tax for merchandise sales.

The figures reported herein are those used in the preparation and filing of the club's tax returns.

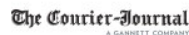
